#### **Family Membership**

Available to one adult person plus either one of the following:

- The spouse or defacto spouse of a member or one additional adult person (aged 18 years or over) in the family or defacto relationship living at the same household (Family Member), plus one additional adult person with Student Concession and must not be more than 25 years old. A Student Concession holder does not need to live at the same address as the primary members but must be a direct family member.
- A child or grandchild of a member who has not attained the age of 18 years (Family Junior Member).
- Receive one ACDS Journal.
- All members in this membership category who have attained the age of 18 have voting rights and are eligible to hold Office at Club, Branch and Federal levels and act as officials; providing they meet the relevant criteria and qualifications.

#### Single Membership

Available to a person who has attained the age of 18 years.

- Receives the ACDS Journal.
- Has voting rights and are eligible to hold Office at Club, Branch and Federal levels and act as
  officials; providing they meet the relevant qualifications.

#### **Junior Membership**

Available to a person who has not attained the age of 18 years and who is not the child of a member.

- Receives the ACDS Journal.
- Do not have voting rights and is not eligible to hold Office at Club, Branch and Federal levels.
- · May attend ACDS schools and training workshops (upon recommendation of Club Committee)
- May be an official; providing they have the relevant qualifications.

#### Active (Non-driving)

Available to persons of any age who do not drive horses/ponies.

- Receives the ACDS Journal.
- Has voting rights and are eligible to hold Office at Club, Branch and Federal levels and act as
  officials; providing they meet the relevant qualifications.
- May attend ACDS schools and training workshops.
